PHILOSOPHY

We have established a commitment to serve our community in the capacity of a Food Bank without condescension and with absolute confidentiality.

GOALS

- > To provide an efficient program of food collection and distribution.
- ➤ To make available donated and purchased food to families and individuals while encouraging our clients towards healthier food options.
- ➤ To take an active role in educating and supporting the public about the food needs in our community.
- > To gather, maintain and keep current, up-dated statistics regarding the food needs of our own community.

GANANOQUE FOOD BANK BACKGROUND

The Gananoque and Area Food Bank was established in 1987 by the Gananoque Ministerial Association (an organization of all local churches), to provide support to individuals and families living in our area whose financial resources were insufficient to cover basic food needs. The Food Bank rented from the local branch of the Royal Canadian Legion for numerous years up to and including September 2020. As of September 25th, 2020 the Food Bank moved to a new location, 497 King St. E, entering into a lease agreement with Gerasimos Bonas.

The Food Bank is funded and sustained through food and monetary donations from individuals, merchants, churches, school food drives, service clubs and local businesses.

The purpose of the Food Bank is to provide temporary food to those in need. All prospective clients are subject to a screening process to determine whether they qualify for assistance under the mandate of the Food Bank.

The affairs of the Food Bank are managed by a Board of Directors with a Chair, Vice Chair, Treasurer and Recording Secretary.

As a member of Feed Ontario and Food Banks Canada (FBC) we are subject to compliance with Feed Ontario Standards of Operation & Operating Policies and to FBC's Code of Ethics.

The Food Bank is open every Monday, Wednesday and Friday from 12:30 p.m. to 2:45 p.m. At the present time we operate with a pool of volunteers from which three or four are drawn to meet the needs of that particular day. All volunteers are required to sign a Confidentiality Agreement to respect the client's privacy.

Since 2021-2022 we have almost doubled the number of clients needing our services in the Gananoque Area. With the rising cost of food items this number is sadly expected to rise.

I would be remiss not to thank our valuable donors. Without their support, our Food Bank would not be able to continue to serve our community. I am also so grateful for our staff, Sandy, and our numerous Volunteers and Board members who give of their time so graciously. Thank you for all that you do!

Despite our challenges, this was a year of positive change for the Food Bank. Below are some of our accomplishments:

- A successful SMILE cookie Campaign with our local Tim Hortons Store which raised over \$8500.
- Successful Christmas Hamper Campaign-Thanks to Mary Elizabeth's Team we were able to increase our hampers to almost 200 this year.
- 3 new Board Members joined us this year, Bob St. Onge, Lynda Beckstead and Mike Cartan.
- The completion of the Volunteer Handbook.
- A fundraising raffle for gift cards which raised almost \$3000.
- The addition of a suggestion box for both volunteers and clients.

In addition, we completed some building maintenance issues including

- The installation of an accessible door and ramp for our clients
- The installation of security cameas
- Revamp of the Pantry Area to accommodate a donation of a Freezer from Gan Chev Olds(Dairy Queen)
- New Ventilation System
- New Eavestroughs thanks to our Landlord
- Exterior lockable mailbox

The next year will be a challenging one. We look forward to the expansion of projects with other community agencies to meet the food insecurity needs of our clients. We also hope to continue to offer healthy, nutritious options to the people we serve and hope that this can be creatively obtained within our yearly budget.

Thank you to all for contributing to our success and I look forward to next year.

MANAGER'S REPORT

The year April 2022 to March 2023 was a much better year as COVID restrictions were lifted. Donations continue to be generous, resulting in our ability to offer a variety of healthy choices, fresh vegetables, fruits and proteins, dairy, as well as other products.

- We continue to partner with Harvest Sharing Food Bank Brockville; Partners in Mission Kingston; Rear of Leeds and Lansdowne Food Bank Seeley's Bay.
- SNAP (a Provincial Government initiative) supplying a variety of goods
- Thanks to Reg Pearce who donated fresh vegetables; Bob Griffin with potatoes.
- Metro continues to have "Buy a Bag" for the food bank. We also receive baked goods weekly through the One Bite Program. Metro presented us with a large monetary and gift card donation.
- No Frills held their food basket Spring and Fall Campaigns
- Rockport Church (Church of the Redeemer) continued their support with numerous food drives throughout the year
- Radio MyFM 99.9 initiated a food drive in September 2021 (Back to school)
- Schools donated food as well as monetary donations
- The annual Ministerial Halloween drive was once again held on Hallowe'en
- Cram the Cruiser (Gananoque Police Service) was held in December
- Melodia Monday reopened this year, bringing in monetary donations.

We remain open for client shopping, allowing them the dignity of shopping for themselves. We continue to prepare boxes for clients wishing delivery service. February saw a revamping of the pantry allowing a larger work area for the volunteers.

There are 39 volunteers and 7 drivers at this time. Such generosity of our donors and time by our volunteers. Thank you. It is very much appreciated.

PUBLIC RELATIONS REPORT

This was a busy year for publicity for the Food Bank. We again increased our visibility by using our Facebook and our Website. Facebook posts advertised significant donations from local Schools, Businesses, Churches, Fire and Police Departments, Community groups and private Donors. In addition, we were able to better advertise events such as Food Drives and Fundraisers that happened throughout the year. Facebook was also beneficial in advertising our donation needs to the community. This was found to be very useful and resulted in significant donations that were needed. We look forward next year to the expansion of our website and future use of our social media platforms to communicate our events to our clients and donors.

We were also very fortunate to work closely with our local newspaper and 99.9MyFM who supported us in advertising our many activities this year. Of special note this year was the Gift Card Raffle, sponsored by Thornbusch Landscaping, which was held throughout the months of February and March. With our volunteers visible by the sale of raffle tickets at local businesses, we were able to gain a better profile during our typically slow period of donations.

We continue to be thankful for our generous community who help us to support our clients with various donations throughout the year.

TREASURER'S REPORT

The world is ever evolving as is our Gananoque Food Bank. Every year it is a challenge in trying to determine what to expect with regards to donations or the number of clients that would be served and the costs to provide these services.

Financial Highlights:

- The year-end financial statement are attached. The actual amount of donations received for this fiscal year was \$169,337.50. The Gananoque and Area community is above and beyond generous, however, due to the economic environment, donations were down by approximately 15% from the previous year.
- Unfortunately, we were unsuccessful in receiving further grants to purchase gift cards, however due to the COVID pandemic and the continuing increase in cost of food, the board passed a motion to continue the gift cards for clients until September 30, 2022.
- The Gananoque Food Bank was fortunate enough to have been successful in receiving a Feeding Possibility Grant via Feed Ontario in the amount of \$25,000. These monies were specifically for the installation of an accessible ramp and door. The landlord was also generous in reducing our rent somewhat for six months to assist with the overall cost of this leasehold improvement, which amounted to a total of \$32,734.04.
- The HST rebates that the food bank is eligible for continue to be applied for on a bi-annual basis.
- Due to the generosity of the community the Gananoque Food Bank invested additional money in short term investments.
- At our June 20 Board meeting a Reserve Fund Policy was passed which updated the Equity Reserve Funds. There are now three Reserve Funds and they are as follows:
 - Operating Restricted Reserve Fund to provide an internal source of funds for situations such as a sudden increase in expenses, one-time unbudgeted expenses, a downturn in donations or uninsured losses.
 - Building Restricted Reserve Fund to provide a ready source of funds for future rent and utilities.
 - Capital Assets Restricted Reserve Fund to provide a ready source of funds for repair or acquisition of equipment and furniture.

Objectives for 2023/2024:

- to review financial policies including the preparation of a purchasing policy
- to oversee income and expenses in comparison with the budget
- to produce and explain monthly financial reports, reporting on exceptions
